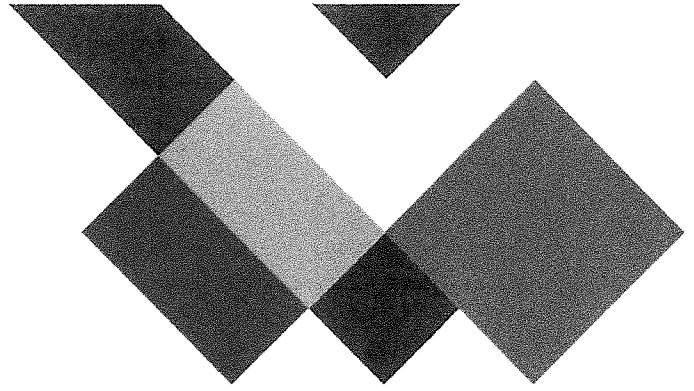

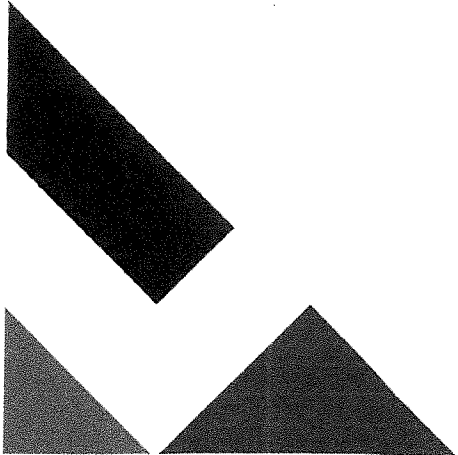

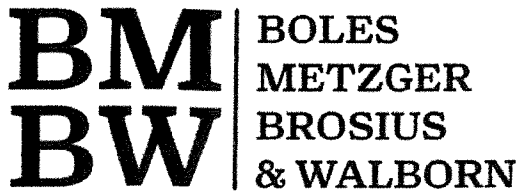

NOTE 1 - PURPOSE AND ORGANIZATION

Main Street Gettysburg, Inc. is incorporated as a nonprofit organization and operates under the laws and regulations of the Commonwealth of Pennsylvania. Main Street Gettysburg is a non-profit organization committed to the preservation and revitalization of Historic Gettysburg for the benefit of its citizens, businesses and visitors. Revenue is derived from contributions, grants and administrative fee income.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The summary of significant accounting policies of Main Street Gettysburg, Inc. is presented to assist in understanding the Organization's financial statements. The financial statements and notes are representations of the Organization's management who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of these financial statements.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Cash and cash equivalents:

For purposes of the statement of cash flows, the Organization considers all highly liquid instruments purchased with an original maturity of three months or less to be cash and cash equivalents. This includes checking, savings and money market accounts. Certain grant agreements require cash and cash equivalents be maintained in separate bank accounts.

Unconditional promises to give:

Unconditional promises to give are recorded at their net realizable value at the time the promises are received. These promises to give are reflected as either current or long-term receivables on the statements of financial position. All long-term receivables are expected to be collected within five years.

Uncollectible accounts:

Management has determined that the pledges receivable and zero-interest loan program receivables are fully collectible; therefore, no allowance for uncollectible accounts is considered necessary at December 31, 2023 and 2022.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Property and equipment:

Property and equipment are recorded at cost. The Organization capitalizes assets purchased with a cost greater than \$1,000. Depreciation on furniture and equipment is provided by the straight-line method over the estimated useful lives of 3 to 7 years.

Deferred revenue:

Income from a portion of brick sales received are deferred and recognized over the periods to which the income is earned.

Net assets classification:

The Organization's net assets are classified as net assets with donor restrictions and net assets without donor restrictions. The net assets without donor restrictions classification is used to account for the portion of expendable funds that are available for support of the Organization's general operations. The net assets with donor restrictions classification is used to account for contributions and grants restricted by the donor.

Contributions:

Contributions restricted by donors are reported as increases in net assets without donor restrictions if the restrictions expire (that is, when a stipulated time restriction ends or purpose restriction is accomplished) in the reporting period in which the revenue is recognized. All other donor-restricted contributions are reported as increases in net assets with donor restrictions, depending on the nature of the restrictions. When a restriction expires, net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statements of activities as net assets released from restrictions

Functional allocation of expenses:

The costs of program and supporting services activities have been summarized on a functional basis in the statements of activities. The statements of functional expenses present the natural classification detail of expenses by function. Accordingly, certain costs have been allocated among the programs and supporting services benefited. The expenses that are allocated include payroll and related expenses and any office related expenses which are allocated on the basis of estimates of time and effort of respective employees.

Income taxes:

The Internal Revenue Service has determined that Main Street Gettysburg, Inc. is exempt from Federal income taxes under Section 501 (a) of the Internal Revenue Code as an organization described in Section 501 (c)(3). Accordingly, contributions to the Organization are deductible for Federal income tax purposes. In addition, the Organization has been classified as an organization that is not a private foundation under Section 509(a)(2).

The Organization has evaluated subsequent events through March 27, 2024, the date which the financial statements were available to be issued.

The organization manages its liquidity and reserves following three guiding principles: operating within a prudent range of financial soundness and stability, maintaining adequate liquid assets to fund near-term operating needs, and maintaining sufficient reserves to provide reasonable assurance that long-term obligations will be discharged. In addition, the organization has an unused line of credit available for future expenditures.

NOTE 4 - LOANS RECEIVABLE

The Organization advances loans to local businesses and individuals for the improvement of property within the Historic District of Gettysburg. These zero interest loans were funded by a restricted grant from the Commonwealth of Pennsylvania and are repaid on a monthly basis. At December 31, 2023 and 2022, the balances on these loans totaled \$1,000 and \$6,550 respectively.

NOTE 5 - PROPERTY AND EQUIPMENT

At December 31, 2023 and 2022, the Organization had property and equipment with an original capitalized cost of \$8,934 and \$7,726, respectively. The accumulated depreciation was \$7,043 and \$6,531, respectively.

NOTE 6 - LINE OF CREDIT

As of December 31, 2023 and 2022, pursuant to an agreement with ACNB Bank, the Organization had available a \$25,000 unsecured line of credit with interest payable at the WSJ Prime rate, plus 0.5%, with a floor of 4.5%, none of which was outstanding.

NOTE 7 - DEFERRED REVENUE

Deferred revenue consists of brick installation revenue of \$825 and \$525 at December 31, 2023 and 2022, respectively.
